Karen's academic background is in social work. She achieved her master's degree from the University of Northern British Columbia in 2007, and graduated from the Indigenous Governance Certificate Program from the University of Victoria in 2010. In August 2022, she successfully completed the Masters in Business Administration from Simon Fraser University in the Indigenous Business Leadership program. She is the first in her family and community to attain two master's degrees.

Karen was named one of the "35 Most Influential Women in BC: The power to disrupt" in March 2016, by BC Business Magazine. And she was elected in three consecutive years, 2021, 2022 and 2023, as one of the Business in Vancouver BC 500: The most influential business leaders in British Columbia, in the Resources: Oil and Gas sector.

Tanishka's efforts in Indigenous consultation focus on building long-lasting relationships and enhancing Indigenous collaboration and partnership in federal environmental and impact assessments.
